RESOLUTION APPROVING AND CONCURRING WITH RESOLUTION NO. 10, SERIES OF 2024 OF THE PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (PDRPMC) OF THE PROVINCE OF NEGROS OCCIDENTAL, APPROVING THE PROPOSED RE-PROGRAMMING OF VARIOUS PROJECTS/PROGRAMS/ACTIVITIES FUNDED UNDER THE 2024 PDRRM FUND TO PROVIDE ASSISTANCE TO THE PROVINCES OF ISABELA, QUIRINO, CAGAYAN, AURORA, IFUGAO, MOUNTAIN PROVINCE, NUEVA VISCAYA, NUEVA ECIJA, AND CATANDUANES AFFECTED BY THE COMBINED EFFECTS OF TROPICAL CYCLONES NIKI, OFEL AND PEPITO IN THE TOTAL AMOUNT OF FOUR MILLION PESOS (P4,000,000.00)

WHEREAS, Section 106 of RA 7160, otherwise known as the Local Government Code of 1991 provides that “each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development councils and approved by its sanggunian”;
