**RESOLUTION AUTHORIZING THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT INCENTIVE (CNAI) IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO EACH QUALIFIED EMPLOYEE AND OFFICIAL OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) CIRCULAR NO. 2024-04 DATED NOVEMBER 11, 2024**

**WHEREAS**, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Resolution No. 080, series of 2024 of the Provincial Alliance of Capitol Employees (PACE) entitled: "Resolution requesting the Provincial Government of Negros Occidental to grant the 2024 Collection Negotiation Agreement Incentive (CNAI) to all qualified members amounting to Thirty Thousand Pesos (P30,000.00)";

**WHEREAS**, the grant of CNA Incentive is pursuant to Department of Budget and Management (DBM) Budget Circular No. 2024-04 dated November 11, 2024, entitled: "Guidelines on the Grant of Collection Negotiation Agreement (CNA) Incentive for FY 2024", which authorizes the grant of CNA Incentive Bonus in a rate not exceeding P30,000.00 for each qualified government employee;

**WHEREAS**, the internal guidelines to be followed in the availment of the CNAI shall be provided by PACE, being the duly recognized bargaining agent, which will indicate the specific criteria for determining who are entitled to receive and the corresponding rate of the said incentive for each qualified employee.
