RESOLUTION AUTHORIZING THE PROGRAMMING OR RE-PROGRAMMING OF FUNDS OF THE PROVINCE OF NEGROS OCCIDENTAL FOR THE REPAIR AND UPGRADING OF PUBLIC INFRASTRUCTURES AND FACILITIES IN THE AFTERMATH OF THE ERUPTION OF KANLAON VOLCANO

**WHEREAS**, the entire Province of Negros Occidental was declared to be under a state of calamity by the Sangguniang Panlalawigan per SP Resolution No. 1446, series of 2024 due to the eruption of Kanlaon Volcano last December 9, 2024;

WHEREAS, the Provincial Disaster Risk Reduction Management Council (PDRRMC) of the Province of Negros Occidental per Resolution No. 11, series of 2024 recommended the declaration of a state of calamity in the entire Province of Negros Occidental following the notice issued by DOST-PHIVOLCS raising the status of Kanlaon Volcano to Alert Level 3;

WHEREAS, in order to facilitate the repair and upgrading of public infrastructures and facilities in the aftermath of the eruption of Kanlaon Volcano, there is a need to authorize the programming and re-programming of the said projects for the immediate rehabilitation efforts of the province;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the programming or re-programming of funds of the Province of Negros Occidental for the repair and upgrading of public infrastructures and facilities in the aftermath of the eruption of Kanlaon Volcano.
