**RESOLUTION NO. 1450**  
**Series of 2024**

**RESOLUTION AUTHORIZING THE UTILIZATION OF THE QUICK RESPONSE FUND (QRF) FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) FUND WITHIN THE AFFECTED LOCAL GOVERNMENT UNITS (LGUs) OR OTHER AREAS IMPACTED BY THE ERUPTION OF KANLAON VOLCANO FOR RELIEF, REHABILITATION, RECONSTRUCTION, RECOVERY AND OTHER NECESSARY WORKS OR SERVICES OF THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL**

**WHEREAS**, the entire Province of Negros Occidental was declared to be under a state of calamity by the Sangguniang Panlalawigan per SP Resolution No. 1446, series of 2024 due to the eruption of Kanlaon Volcano last December 9, 2024;

**WHEREAS**, the Provincial Disaster Risk Reduction Management Council (PDRRMC) of the Province of Negros Occidental per Resolution No. 11, series of 2024 recommended the declaration of a state of calamity in the entire Province of Negros Occidental following the notice issued by DOST-PHIVOLCS raising the status of Kanlaon Volcano to Alert Level 3;

**WHEREAS**, in order to facilitate the relief, rehabilitation, reconstruction, recovery and other necessary works or services of the Provincial Government of Negros Occidental within the Local Government Units and other areas impacted by the eruption of Kanlaon Volcano, there is a need to authorize the utilization of the Quick Response Fund from the Local Disaster Risk Reduction and Management Fund;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present,
