WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2024-02, of the Municipality of Cauayan, Negros Occidental for the 2024 General Fund Supplemental Budget No. 2 of the said municipality in the amount of Six Million Four Hundred Twenty Thousand Pesos (P6,420,000.00) that was submitted to the Sangguniang Panlalawigan on November 26, 2024;
