### RESOLUTION NO. 1469 Series of 2024

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00)

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of Hinoba-an, Negros Occidental with a total appropriation of P2,000,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-06;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as prereviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-06 of the Municipality of Hinoba-an covering the 2024 General Fund Supplemental Budget No. 5 of the said municipality with a total appropriation of P2,000,000.00 and considered operative in its entirety effective October 16, 2024, subject to the posting requirement under Section 59 of LGC 1991.
