**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00)**


**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of Hinoba-an, Negros Occidental with a total appropriation of P2,000,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-06;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

**WHEREAS**, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 2024-06 of the Municipality of Hinoba-an covering the 2024 General Fund Supplemental Budget No. 5 of the said municipality with a total appropriation of P2,000,000.00 and considered operative in its entirety effective October 16, 2024, subject to the posting requirement under Section 59 of LGC 1991.
