WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 03, Series of 2024 of the Municipality of Isabela, Negros Occidental entitled: “AN ORDINANCE APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF NINE MILLION FOUR HUNDRED NINETY THREE THOUSAND THREE HUNDRED THIRTY PESOS AND 01/100 (P9,493,330.01);

WHEREAS, the pre-review shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

WHEREAS, it is recommended for approval and considered operative in its entirety effective October 16, 2024 subject to the posting requirements under Section 59 of LGC 1991 and subject further to the following conditions and reminders, to wit:

1. *The implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to Executive Order No. 64 shall be in accordance with the provisions of Local Budget Circular No. 160 dated August 12, 2024 of the Department of Budget and Management;*

2. *The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018, Budget Circular No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023, of the Department of Budget and Management (DBM);*
3. *The utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020 and consistent with the approved Annual Investment Plan (AIP) and/or Supplemental Annual Investment Plan (SAIP);*
4. *The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the Implementing Rules and Regulations of RA 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013; and*
5. *The Gender and Development (GAD) Plan and Budget shall be prepared pursuant to RA No. 7192, RA 9710 and Philippine Commission on Women-DILG-DBM-NEDA JMC No. 2016-01 dated January 12, 2016 and that the same be reviewed and endorsed by the DILG.*

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 03, Series of 2024 of the Municipality of Isabela, Negros Occidental entitled: "AN ORDINANCE APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF NINE MILLION FOUR HUNDRED NINETY THREE THOUSAND THREE HUNDRED THIRTY PESOS AND 01/100 (P9,493,330.01);
