- 2. The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10,2018, Budget Circular No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023, of the Department of Budget and Management (DBM);
- 3. The utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020 and consistent with the approved Annual Investment Plan (AIP) and/or Supplemental Annual Investment Plan (SAIP);
- 4. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the Implementing Rules and Regulations of RA 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013; and
- 5. The Gender and Development (GAD) Plan and Budget shall be prepared pursuant to RA No. 7192, RA 9710 and Philippine Commission on Women-DILG-DBM-NEDA JMC No. 2016-01 dated January 12, 2016 and that the same be reviewed and endorsed by the DILG.
