RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 06, SERIES OF 2024 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION FIVE HUNDRED SEVENTY THREE THOUSAND NINE HUNDRED FIFTY TWO PESOS (P2,573,952.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 6 of the Municipality of E.B. Magalona, Negros Occidental with a total appropriation of P2,573,952.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 06, series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 06, series of 2024 of the Municipality of E.B. Magalona covering the 2024 General Fund Supplemental Budget No. 6 of the said municipality with a total appropriation of P2,573,952.00 and considered operative in its entirety, subject to the posting requirement under Section 59 of LGC 1991 and subject further to the following conditions:

1. That the Local Chief Executive, upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which proves that, "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod and Sangguniang Bayan shall be presented to the Provincial Governor of City or Municipal Mayor, as the case may be. If the LCE concerned approves the same, he shall affix his signature on each and every page thereof... xxx;
2. Strict adherence in the period as to the submission of AOs to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that, "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
