**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-04 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 3 OF THE SAID MUNICIPALITY IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00)**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 3 of the Municipality of Calatrava, Negros Occidental with a total appropriation of P150,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-04;
