RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-09 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 9 OF THE SAID CITY IN THE AMOUNT OF FOUR HUNDRED EIGHTY THOUSAND TWO HUNDRED THIRTY ONE PESOS (P480,231.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 9 of the City of La Carlota, Negros Occidental with a total appropriation of P480,231.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2024-09;
