RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 24-08 OF THE CITY OF BAGO, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 8 OF THE SAID CITY IN THE AMOUNT OF FORTY FOUR MILLION SEVEN HUNDRED THIRTY SEVEN THOUSAND ONE HUNDRED FORTY PESOS AND SIXTY CENTAVOS (P44,737,140.60)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 8 of the City of Bago, Negros Occidental with a total appropriation of Forty Four Million Seven Hundred Thirty Seven Thousand One Hundred Forty Pesos and Sixty Centavos (P44,737,140.60), enacted by the Sangguniang Panlungsod of the said city per Appropriation Ordinance No. 24-08;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 24-08 of the City of Bago, Negros Occidental, and considered operative in its entirety effective October 15, 2024 subject to the following reminders and conditions:

- The posting requirements under Section 59 of the Local Government Code of 1991;
- 2. The Local Chief Executive, upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the Local Government Code of 1991, which provides that: "Every ordinance enacted by the sangguniang panlalawigan, sangguniang panlungsod, or sangguniang bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the local chief executive concerned approves the same, he shall affix his signature on each and every page thereof... x x x

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.
