RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF THE CITY OF SIPALAY RELATIVE TO THE DONATION OF EIGHT (8) SETS MPA BUOY MARKERS (SPECIFICALLY DESCRIBED IN THE DEED) WITH A TOTAL AMOUNT OF THREE HUNDRED THIRTY FIVE THOUSAND SIX HUNDRED PESOS (P335,600.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Deed of Donation to be executed by the Province of Negros Occidental in favor of the City of Sipalay relative to the donation of eight (8) sets MPA Buoy Markers (specifically described in the deed) with a total amount of Three Hundred Thirty Five Thousand Six Hundred Pesos (P335,600.00);
