**RESOLUTION NO. 1490
Series of 2024**

***RESOLUTION APPROVING CITY ORDINANCE NO. 740, SERIES OF 2024 OF THE
CITY OF TALISAY, NEGROS OCCIDENTAL, ENTITLED: “AN ORDINANCE
CREATING POSITIONS IN THE DIFFERENT OFFICES IN THE CITY GOVERNMENT
OF TALISAY, NEGROS OCCIDENTAL***

WHEREAS, thereby presented to the Board for review and appropriate action is City Ordinance No. 740, series of 2024 of the City of Talisay, Negros Occidental, entitled: “An Ordinance creating positions in the different offices in the City Government of Talisay, Negros Occidental;

WHEREAS, the power of the sangguniang panlungsod to enact ordinances, is well entrenched in the Local Government Code of 1991 (RA 7160) under Article 458, thus:

“Article 458 (a) The sangguniang panglungsod, as the legislative body of the city, shall enact ordinance, and shall:

(1) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection, shall:

(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees”

WHEREAS, Section 76 of the Code provides that “every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and regulations prescribed by the Civil Service Commission;”

WHEREAS, the creation of plantilla positions should be in consonance with Section 325 of RA 7160, stating, among others, that “the total appropriations, whether annual or supplemental, for personal services of a local government unit for one fiscal year shall not exceed forty-five percent (45%) in the case of first to third class provinces, cities, and municipalities, and fifty-five percent (55%) in the case of fourth class or lower, of the total annual income from regular sources realized in the next preceding fiscal year.”

WHEREAS, Section 2 of the subject ordinance has explicitly provided that “the appropriation for compensation and other remuneration of the personnel in the created positions shall be provided in the Supplemental Budget 2 of the City, fiscal year 2024;”

WHEREAS, in view of the foregoing, the SP Committee on Human Resource, recommends approval of the same;

NOW THEREFORE, on motion of Hon. Manuel Frederick O. Ko, and unanimously seconded by all the members present,


