***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE CITY OF SILAY AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE REFERRAL OF PATIENTS OF THE SILAY CITY HEALTH OFFICE NEEDING X-RAY AND LABORATORY EXAMINATIONS, PHARMACY AND DIAGNOSTIC SERVICES COVERED BY THE E-KONSULTA PACKAGE OF THE PHILHEALTH TO THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the City of Silay and the Province of Negros Occidental relative to the referral of patients of the Silay City Health Office needing x-ray and laboratory examinations, pharmacy and diagnostic services covered by the E-konsulta Package of the Philhealth to the Teresita L.
