(NOMPAI) RELATIVE TO THE COLLABORATION OF BOTH PARTIES FOR THE PLANNING AND IMPLEMENTATION OF ENVIRONMENTAL AND NATURAL RESOURCES PROGRAMS, PROJECTS AND ACTIVITIES WITHIN THE PROVINCE OF NEGROS OCCIDENTAL
