RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2024-009 OF THE MUNICIPALITY OF CANDONI, NEGROS OCCIDENTAL, CREATING ONE (1) PHARMACIST I, ONE (1) ADMINISTRATIVE AIDE IV, TWO (2) AGRICULTURAL TECHNICIAN II, AND ONE (1) FARM WORKER POSITIONS UNDER THE EXECUTIVE DEPARTMENT, OF THE SAID MUNICIPALITY AS VALIDLY ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Municipal Ordinance No. 2024-009 of the Municipality of Candoni, Negros Occidental, entitled: "*CREATING ONE (1) PHARMACIST I, ONE (1) ADMINISTRATIVE AIDE IV, TWO (2) AGRICULTURAL TECHNICIAN II, AND ONE (1) FARM WORKER POSITIONS UNDER THE EXECUTIVE DEPARTMENT, MUNICIPALITY OF CANDONI, NEGROS OCCIDENTAL, PROVIDING FOR THE QUALIFICATIONS, AND OTHER PURPOSES RELATED THERETO* " was submitted for review by the Municipality of Candoni to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, it is the recommendation of the said Office that the subject ordinance is within the conferred powers of its Sanggunian to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;
