RESOLUTION DISAPPROVING RESOLUTION NO. 2024-165 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL, APPROVING MDC RESOLUTION NO. 2024-22, "RESOLUTION AMENDING THE 2024 ANNUAL INVESTMENT PROGRAM"

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-165 of the Municipality of La Castellana, Negros Occidental, approving MDC Resolution No. 2024-22, "Resolution Amending the 2024 Annual Investment Program";

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the powers of the Sangguniang Bayan of La Castellana to enact pursuant to the pertinent provisions of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipality of La Castellana however failed to submit/attach a copy of the Amended 2024 AIP which is the subject for approval of the said resolution;

WHEREAS, in view of the foregoing, the SP Committee on Finance favorably endorsed the same for disapproval without prejudice to its re-submission after substantial compliance is made;
