RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06A, OF THE CITY OF ESCALANTE, NEGROS OCCIDENTAL APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID CITY IN THE TOTAL AMOUNT OF THIRTY ONE MILLION EIGHT HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED SIXTY NINE PESOS AND FORTY EIGHT CENTAVOS (P31,818,569.48)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2024-06A, of the City of Escalante, Negros Occidental for the 2024 General Fund Supplemental Budget No. 6 of the said city in the amount of Thirty One Million Eight Hundred Eighteen Thousand Five Hundred Sixty Nine Pesos and Forty Eight Centavos (P31,818,569.48) that was submitted to the Sangguniang Panlalawigan on December 6, 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-06A, of the City of Escalante, Negros Occidental for the 2024 General Fund Supplemental Budget No. 6 of the said city in the amount of Thirty One Million Eight Hundred Eighteen Thousand Five Hundred Sixty Nine Pesos and Forty Eight Centavos (P31,818,569.48) subject to the following conditions:

1. The utilization of 5% Local Disaster Risk Reduction and Management Fund shall be in accordance with the provisions of RA 10121 and its Implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013. Furthermore, the LDRRM Plan of the City should be reviewed by the Office of the Civil Defense pursuant to Section 9e if RA No. 10121;
2. The purchase and specifications of the motor vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022, and BC N0. 2022-1A dated March 1, 2023.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.
