RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-07 OF THE CITY OF ESCALANTE, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 7 OF THE SAID CITY IN THE AMOUNT OF ELEVEN MILLION FOUR HUNDRED SEVENTEEN THOUSAND FORTY SEVEN PESOS AND THIRTY SIX CENTAVOS (P11,417,047.36)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 7 of the City of Escalante, Negros Occidental with a total appropriation of Eleven Million Four Hundred Seventeen Thousand Forty Seven Pesos and Thirty Six Centavos (P11,417,047.36), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2024-07;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;
