RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-10 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 10 OF THE SAID CITY IN THE AMOUNT OF THIRTY ONE MILLION ONE HUNDRED SIXTY ONE THOUSAND TWENTY THREE PESOS AND FIFTEEN CENTAVOS (P31,161,023.15)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 10 of the City of La Carlota, Negros Occidental with a total appropriation of Thirty One Million One Hundred Sixty One Thousand Twenty Three Pesos and Fifteen Centavos (P31,161,023.15), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2024-10;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-10 of the City of La Carlota, Negros Occidental, and considered operative in its entirety effective October 29, 2024, subject to the following conditions:


1. Posting requirements under Section 59 of the Local Government Code of 1991;
2. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the Implementing Rules and Regulations of Republic Act No. 10121, Commission of Audit Circular No. 2012-02 dated September 12, 2012 and National Disaster Risk and Reduction Management Council-Department of Budget and Management-Department of Interior and Local Government Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
3. The City of La Carlota is encouraged to strictly adhere to the period of submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of Republic Act No. 7160, which states that: "*Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) Within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils.*"

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
