RESOLUTION APPROVING THE LETTER OFFER WITH THE TERMS OF REFERENCE FOR THE ELECTROMAGNETIC ENERGY-FLUX REACTOR-STATIONARY POWER GENERATION (EER SPG)

WHEREAS, Section 20 of Article II of the 1987 Philippine Constitution provides that “The State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments”;

WHEREAS, to implement the above-cited Constitutional provision, Republic Act No. 11966, also known as the “Public-Private Partnership (PPP) Code of the Philippines” was enacted;

WHEREAS, pursuant to Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991, Local Government Units (LGUs) shall, within their respective territorial jurisdictions, enhance their economic prosperity, and the general welfare of their inhabitants;

WHEREAS, the Provincial Government of Negros Occidental (PGNO) recognizes the responsibility for the development, promotion, and management of renewable power resources in the Province, thereby maintaining its value for human survival and as a critical source of energy for domestic, agricultural, industrial use and for other sustainable applications to support the socio-economic growth of the province;

WHEREAS, the PGNO, in its pursuit of achieving a transformative renewable energy for its constituents has initiated to submit a Letter Offer to the Honorable Governor, Eugenio Jose V. Lacson, along with the Terms of Reference for an Electromagnetic Energy-Flux Reactor-Stationary Power Generation (EER SPG), which is proposed to supply a rate of 6.00 PHP per Kwh (Baseload Rate at 100% Load Factor);

NOW THEREFORE, on motion of Hon. Hon. Manuel Frederick O. Ko, unanimously seconded by all the members present,


