RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE JOINT VENTURE AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE DIGITAL OUT OF HOME INCORPORATED (DOOH) AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE ENGAGEMENT OF BOTH PARTIES IN AN ADVERTISING AGREEMENT, WHEREIN DOOH WILL INSTALL STATIC OR DIGITAL DISPLAYS ON VARIOUS PROPERTIES OF THE PROVINCE WITH AN AGREEMENT TO ENGAGE IN THE GROSS SHARING OF THE PROFITS MADE THEREIN

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor authority to sign, for and in behalf of the province, the Joint Venture Agreement to be entered into by and between the Digital Out of Home Incorporated (DOOH) and the Province of Negros Occidental relative to the engagement of both parties in an advertising agreement, wherein DOOH will install static or digital displays on various properties of the province with an agreement to engage in the gross sharing of the profits made therein;

WHEREAS, the subject Joint Venture Agreement is in order and in accordance with Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which provides for the exercise of the powers of the local government unit for effective governance, and the promotion of the general welfare;
