RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE DEPARTMENT OF EDUCATION, DIVISION OF NEGROS OCCIDENTAL RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE FOR THE IMPLEMENTATION OF THEIR PROJECT ENTITLED: "COMPREHENSIVE SCHOOL-BASED CHILD PROTECTION PROGRAM" IN THE AMOUNT OF ONE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS (P1,680,000.00) CHARGEABLE AGAINST THE PCPC FUND
