**WHEREAS**, thereby presented to the Board for appropriate action of the Sangguniang Panlalawigan is Appropriation Ordinance No. 24-11 of the City of Bago, Negros Occidental entitled: “AN APPROPRIATION ORDINANCE AUTHORIZING AN APPROPRIATION IN THE AMOUNT OF TWELVE MILLION THIRTY THOUSAND TWO HUNDRED EIGHTY-FOUR PESOS AND SIXTY-EIGHT CENTAVOS (P12,030,284.68)”;

**WHEREAS**, the pre-review shows apparent compliance with the same law and its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;
