RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-09 OF THE CITY OF ESCALANTE, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 8 OF THE SAID CITY IN THE AMOUNT OF SIXTEEN MILLION THREE HUNDRED THOUSAND PESOS (P16,300,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 8 of the City of Escalante, Negros Occidental with a total appropriation of P16,300,000.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2024-09;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;
