RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 24-05 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, COVERING THE FY 2024 SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF FIFTEEN MILLION SEVEN HUNDRED THOUSAND PESOS (P15,700,000.00) FOR THE GENERAL FUND AND FOUR MILLION TWO HUNDRED FORTY THOUSAND PESOS (P4,240,000.00) FOR THE LOCAL ECONOMIC ENTERPRISES OF THE SAID CITY

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 Supplemental Budget No. 4 of the City of San Carlos, Negros Occidental in the amount of Fifteen Million Seven Hundred Thousand Pesos (P15,700,000.00) for the General Fund and Four Million Two Hundred Forty Thousand Pesos (P4,240,000.00) for the Local Economic Enterprises, enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 24-05;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition, implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;


1. Posting requirement under Section 59 of the Local Government Code (LGC) of 1991;
2. The grant of Service Recognition Incentive for FY 2024 shall be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024;
3. That Section 54 of the LGC of 1991 provides that every ordinance enacted by the sanggun shall be presented to the city mayor, as the case may be. If the local chief executive concerned approves the same, he shall affix his signature on each and every page thereof.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
