THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-08 of the City of Himamaylan, Negros Occidental for the 2024 General Fund Supplemental Budget No. 7 of the said city in the amount of Fourteen Million Two Hundred Eighty Thousand Pesos (P14,280,000.00) subject to the following conditions:

- The grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2024 shall be subject to the guidelines of Budget Circular No. 2024-4, dated November 11, 2024 of the Department of Budget and Management.
- 2. The local government unit must adopt the correct format of Local Budget Preparation Form No. 9 (Statement of Supplemental Appropriation), as illustrated under page 71 of the Budget Operations Manual for Local Government Units 2023 Edition, and indicate the proper AIP reference codes under column three (3) thereof. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP;
- 3. The Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54 (a) of the LGC, which provides that, "every ordinance enacted by the Sangguniang Panlalwigan, Sangguniang Panlungsod, or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. Ife the LCE concerned approves the same, he shall affix his signature on each and every page thereof;
- 4. Strict Adherence in the period as the submission of Appropriation Ordinances to the Sanggunaing Panlalwigan for review per Section 56(a) of R.A. 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan (a) within three (3) days after approval, the secretary to the Sangguniang Panlalawigan for Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils;"

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

## ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
