***RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 12, SERIES OF 2024 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 8 OF THE SAID MUNICIPALITY AMOUNTING TO FIVE MILLION ONE HUNDRED SEVENTY FOUR THOUSAND SIX HUNDRED FORTY THREE PESOS AND EIGHTY FOUR CENTAVOS (P5,174,643.84)***

***WHEREAS***, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 8 of the Municipality of E.B. Magalona, Negros Occidental, with a total appropriation of Five Million One Hundred Seventy Four Thousand Six Hundred Forty Three Pesos and Eighty Four Centavos (P5,174,643.84), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 12, Series of 2024;

***WHEREAS***, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

***WHEREAS***, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve and declare operative in its entirety effective December 12, 2024, the Appropriation Ordinance No. 12, Series of 2024 of the Municipality of E.B. Magalona, Negros Occidental, subject to the posting requirements under Section 59 of LGC 1991 and the condition that the utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the Implementing Rules and Regulations of R.A. 10121, COA Circular No. 2012-02 dated September 12, 2012, and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.


**RESOLVED FURTHER**, that the Municipality of E.B. Magalona, Negros Occidental is reminded to observe strict adherence in the period as to the submission of Appropriation Ordinance to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan-(a) Within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

**RESOLVED FURTHERMORE**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
