RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 6, SERIES OF 2024 OF THE MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF ONE MILLION SIX HUNDRED SEVENTEEN THOUSAND PESOS (P1,617,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of Murcia, Negros Occidental with a total appropriation of P1,617,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 6, series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as prereviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 6, series of 2024 of the Municipality of Murcia covering the 2024 General Fund Supplemental Budget No. 5 of the said municipality with a total appropriation of P1,617,000.00 and considered operative in its entirety effective December 23, 2024, subject to the posting requirement under Section 59 of LGC 1991 with the following conditions and reminders:

- 1. the grant of Gratuity Pay for COS and JO workers shall be in accordance with the provisions of Budget Circular No. 2024-8, dated December 20, 2024 of the DBM;
- 2. the LGU is reminded to indicate the proper AIP reference code under column three (3) of the LBPF No. 9. The AIP reference code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP; and
- 3. strict adherence in the period as to the submission of AOs to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
