***RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 008, SERIES OF 2024 OF THE MUNICIPALITY OF MANAPLA, NEGROS OCCIDENTAL COVERING SUPPLEMENTAL BUDGET NO. 006 OF THE SAID MUNICIPALITY AMOUNTING TO NINE HUNDRED FORTY FIVE THOUSAND PESOS (P945,000.00)***

***WHEREAS***, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the Supplemental Budget No. 006 of the Municipality of Manapla, Negros Occidental, with a total appropriation of Nine Hundred Forty Five Thousand Pesos (P945,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 008, Series of 2024;

Section 59 of LGC and further subject to the following conditions and reminders:

1. The grant of the Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in as Government Employees for FY 2024 must be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024 of the Department of Budget and Management.
2. That, Section 56 in relation with Sections 326 of the Local Government Code provides that within three (3) days after approval of the Ordinance authorizing annual/supplemental appropriation, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
