RESOLUTION NO. 0133 Series of 2025

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-005 OF THE CITY OF KABANKALAN, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY AMOUNTING TO ONE HUNDRED FOUR MILLION NINETEEN THOUSAND FOUR HUNDRED PESOS (₱104,019,400.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 4 of the City of Kabankalan, Negros Occidental, with a total appropriation of One Hundred Four Million Nineteen Thousand Four Hundred Pesos (₱104,019,400.00), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2024-005;

WHEREAS, the above-mentioned budget shows substantial compliance with the same law, its Implementing Rules and Regulations, with Budget Operations Manual for Local Government Unit, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective November 27, 2024, the Appropriation Ordinance No. 2024-005 of the City of Kabankalan, Negros Occidental, subject to the posting requirements under Section 59 of LGC 1991 and subject further to the following conditions and reminders:

- The purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the Department of Budget and Management (DBM);
- 2. The disbursement of Donations shall be used solely for public purposes and subject to Section 36 and 305(b), 335 and 351 of the LGC of 1991;
- 3. The utilization and disbursement of appropriations for Confidential Expenses shall be subject to the provisions of the Guidelines on the Entitlement, Release, Use, Reporting, and Audit of Confidential and/or Intelligence Funds per Joint Circular 2015-01 dated January 8, 2015 of the CoA, DBM, DILG,GC for GOCCs and DND and it should not exceed thirty percent (30%) of the total annual amount allocated for Peace and Order Program (POP) of the LGU as approved by the Peace and Order Council;
- 4. Strict adherence in the period as to submission of Appropriation Ordinance to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan-(a) Within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
