***RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-07, SERIES OF 2024 OF THE CITY OF CADIZ, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID CITY IN THE AMOUNT OF FIFTY SEVEN MILLION SIX HUNDRED EIGHTY THREE THOUSAND PESOS (P57,683,000.00)***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 5 of the City of Cadiz, Negros Occidental with a total appropriation of Fifty Seven Million Six Hundred Eighty Three Thousand Pesos (P57,683,000.00), enacted by the Sangguniang Panlungsod per Appropriation Ordinance No. 2024-07, Series of 2024;

***WHEREAS***, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, CY 2023 Budget Operations Manual for Local Government Units and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve and consider operative in its entirety effective December 19, 2024, the Appropriation Ordinance No. 2024-07, Series of 2024 of the City of Cadiz, Negros Occidental, subject to the posting requirements under Section 59 of the Local Government Code (LGC) of 1991 and with the following conditions and reminders:

1. The grant of Collective Negotiation Agreement Incentive shall be in accordance with the provisions of Budget Circular No. 2024-4 dated November 11, 2024 of the Department of Budget and Management;
2. The disbursement of Donations shall be used solely for public purposes and subject to Section 36 and 305(b) of the LGC of 1991;
3. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with Republic Act No. 10121 and its Implementing Rules and Regulations, Commission on Audit Circular No. 2012-02 dated September 12, 2012 and National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of Interior and Local Government Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
4. The utilization of the share from national wealth shall be in accordance with the provisions of Section 294 of the LGC;
5. The Local Chief Executive, upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the Local Government Code of 1991, which provides that: *"Every ordinance enacted by the sangguniang panlalawigan, sangguniang panlungsod, or sangguniang bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the local chief executive concerned approves the same, he shall affix his signature on each and every page thereof... x x x x x x; and*
6. Strict adherence in the period as to the submission of Appropriation Ordinance to the Sangguniang Panlalawigan for review per Section 56(a) of Republic Act 7160, which states that: *"Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan. (a) Within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".*

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.
