RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-08 OF THE CITY OF CADIZ, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID CITY IN THE AMOUNT OF FORTY SIX MILLION ONE HUNDRED THIRTY FIVE THOUSAND TWO HUNDRED SIXTY SEVEN PESOS (P46,135,267.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 6 of the City of Cadiz, Negros Occidental with a total appropriation of P46,135,267.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2024-08;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-08 of the City of Cadiz covering the 2024 General Fund Supplemental Budget No. 6 of the said city with a total appropriation of P46,135,267.00 and considered operative in its entirety effective December 20, 2024, subject to the posting requirement under Section 59 of LGC 1991 with the following conditions and reminders:

1. the grant of SRI to shall be in accordance with the provisions of Budget Circular No. 2024-7, dated December 16, 2024 of the DBM;
2. the grant of Gratuity Pay for COS and JO workers shall be in accordance with the provisions of Budget Circular No. 2024-8, dated December 20, 2024 of the DBM;
3. the disbursement of Donations shall be solely for public purposes and subject to Section 36 and 305(b), 335 and 351 of the LGC of 1991;
4. that the Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that "every ordinance enacted by the Sangguniang Panlalawigan, Sangguniang Panlungsod or Sangguniang Bayan shall be presented to the provincial governor or city or municipal mayor, as the case maybe. If the Local Chief Executive approves the same, he shall fix his signature on each and every page thereof, xxx; and
5. strict adherence in the period as to the submission of AOs to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan – (a) within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
