**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-14 OF THE CITY OF LA CARLOTA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 13 OF THE SAID CITY IN THE AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PESOS (P2,700,000.00)**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 13 of the City of La Carlota, Negros Occidental with a total appropriation of P2,700,000.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 2024-14;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 

**RESOLVED FURTHER**, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.
