RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 1, SERIES OF 2024, OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, COVERING THE FY 2024 SUPPLEMENTAL BUDGET NO. 1 OF THE SAID CITY IN THE AMOUNT OF TWO HUNDRED SIXTY TWO MILLION FORTY ONE THOUSAND FOUR HUNDRED SIXTY ONE PESOS AND SIXTY NINE CENTAVOS (P262,041,461.69)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 Supplemental Budget No. 1 of the City of Talisay, Negros Occidental with a total appropriation of Two Hundred Sixty Two Million Forty One Thousand Four Hundred Sixty One Pesos and Sixty Nine Centavos (P262,041,461.69), enacted by the Sangguniang Panglungsod per Appropriation Ordinance No. 1, Series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of RA 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety, the Appropriation Ordinance No. 1, Series of 2024, of the City of Talisay, Negros Occidental, subject to the posting requirements under Section 59 of the Local Government Code (LGC) of 1991, with the following conditions and reminders:

1. The disbursement of Donations shall be used solely for public purposes and subject to Section 36 and 305(b) of the LGC of 1991;
2. The utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular No. 1 of the Department of Budget and Management, Department of Finance and Department of Interior and Local Government dated November 4, 2020 and consistent with the approved Annual Investment Plan;
3. Strict adherence in the period as to the submission of Appropriation Ordinance to the Sangguniang Panlalawigan for review per Section 56(a) of Republic Act 7160, which states that: *"Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan. (a) Within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils"*.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
