RESOLUTION APPROVING ORDINANCE NO. 25-01 OF THE CITY OF BAGO, NEGROS OCCIDENTAL, ENTITLED: "AN AMENDATORY ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 19-03 AS AMENDED BY THE CITY ORDINANCE NO. 19-06, OTHERWISE KNOWN AS "AN ORDINANCE SETTING THE WAGE OF CASUAL PERSONNEL UNDER JOB ORDER IN THE CITY OF BAGO"

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 25-01 of the City of Bago, Negros Occidental, entitled: "An Amendatory Ordinance amending Section 2 of the City Ordinance No. 19-03 as amended by the City Ordinance No. 19-06, otherwise known as "An Ordinance setting the wage of casual personnel under job order in the City of Bago," was submitted for review by the City of Bago to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, the enactment of the subject ordinance is in line with the constitutional mandate to promote social justice and the welfare of workers, particularly those in employment such as Job Order Personnel;

WHEREAS, the subject ordinance revises the daily wage rates for job order personnel, reflecting a progressive adjustment aimed at easing the economic burden on these employees;
