RESOLUTION APPROVING THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. MARK VINCENT V. PUERTAS RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS JUNIOR CONSULTANT AT THE IGNACIO L. ARROYO SR. MEMORIAL DISTRICT HOSPITAL FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Mark Vincent V. Puertas relative to the engagement of his services as Junior Consultant at the Ignacio L. Arroyo Sr. Memorial District Hospital for the period of January 1, 2025 – December 31, 2025;

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, the party shall render not less than and not more than twenty-four (24) hours per tour of duty and shall not exceed eight (8) duties per month and shall receive the rate of Eight Thousand Pesos (P8,000.00) per 24-hours duty;

WHEREAS, the Consultancy Agreement is in order and conforms to the requirements on the law of contracts;
