SYLVIE L. LAZALITA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS JUNIOR CONSULTANT AT THE ELEUTERIO T. DECENA MEMORIAL HOSPITAL FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025 WITH A RATE OF EIGHT THOUSAND PESOS (P8,000.00) PER 24-HOUR DUTY
