RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HON. EUGENIO JOSE V. LACSON, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND BARANGAY GUINTORILAN, MUNICIPALITY OF SAN ENRIQUE RELATIVE TO THE FINANCIAL ASSISTANCE THAT WILL BE EXTENDED BY THE PROVINCE FOR THEIR PROJECT "IMPROVEMENT AND EXTENSION OF BARANGAY COMMUNITY CENTER", IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO BE TAKEN FROM THE 2024 SUBSIDY TO LGUS
