RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONTRACT FOR ELECTRIC SERVICE (CFES) TO BE ENTERED INTO BY AND BETWEEN THE NEGROS ELECTRIC AND POWER CORP. (NEGROS POWER) AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE APPLICATION OF THE PROVINCE FOR THE INSTALLATION OF A 3-PHASE LINE EXTENSION, TRANSFORMER AND OTHER ELECTRICAL WORKS AT THE NEGROS OCCIDENTAL LANGUAGE INFORMATION CENTER GLOBAL CAMPUS; AND THE APPLICATION FORM FOR SERVICE CONNECTION AND OTHER DOCUMENTS WITH REGARD TO THE POWER ENERGIZATION OF SAID CAMPUS
