RESOLUTION APPROVING ON SECOND READING THE PROPOSED ORDINANCE INSTITUTIONALIZING THE TOBACCO REGULATION ACT (REPUBLIC ACT NO. 9211) AND THE VAPORIZED NICOTINE AND NON-NICOTINE PRODUCTS REGULATION ACT (REPUBLIC ACT NO. 11900) TO PROMOTE A SMOKE-FREE ENVIRONMENT IN THE PROVINCE OF NEGROS OCCIDENTAL

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the proposed ordinance, entitled: "An Ordinance Institutionalizing the Tobacco Regulation Act (Republic Act No. 9211) and the Vaporized Nicotine and Non-Nicotine Products Regulation Act (Republic Act.
