INSTITUTIONALIZING THE TOBACCO REGULATION ACT (REPUBLIC ACT NO.
9211) AND THE VAPORIZED NICOTINE AND NON-NICOTINE PRODUCTS
REGULATION ACT (REPUBLIC ACT NO. 11900) TO PROMOTE A SMOKE-FREE
ENVIRONMENT IN THE PROVINCE OF NEGROS OCCIDENTAL***
