RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 13, SERIES OF 2024 OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 9 IN THE AMOUNT OF SEVEN MILLION THREE HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED EIGHTY TWO PESOS AND NINETY SEVEN CENTAVOS (P7,317,582.97) AND THE FOLLOWING FOR THE OPERATION OF THE ECONOMIC ENTERPRISE IN THE TOTAL AMOUNT OF FOUR MILLION FOUR HUNDRED FIFTY FOUR THOUSAND FIVE HUNDRED FOUR PESOS AND THIRTY CENTAVOS (P4,454,504.30), TO WIT: CEMETERY (SUPPLEMENTAL BUDGET NO. 01) – NINE HUNDRED SIXTEEN THOUSAND THREE HUNDRED EIGHTY PESOS AND NINETY FOUR CENTAVOS (P916,380.94); MARKET (SUPPLEMENTAL BUDGET NO. 3) – ONE MILLION TWO HUNDRED FIFTY SIX THOUSAND NINE HUNDRED FIFTY NINE PESOS AND SIXTY SEVEN CENTAVOS (P1,256,959.67); WATERWORKS (SUPPLEMENTAL BUDGET NO. 2) – TWO MILLION TWO HUNDRED EIGHTY ONE THOUSAND ONE HUNDRED SIXTY THREE PESOS AND SIXTY NINE CENTAVOS (P2,281,163.69)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 9 of the Municipality of E.B. Magalona, Negros Occidental with a total appropriation of Seven Million Three Hundred Seventeen Thousand Five Hundred Eighty Two Pesos And Ninety Seven Centavos (P7,317,582.97) and the following for the Operation of the Economic Enterprise in the total amount of Four Million Four Hundred Fifty Four Thousand Five Hundred Four Pesos and Thirty Centavos (P4,454,504.30), to wit: Cemetery (Supplemental Budget No. 01) – Nine Hundred Sixteen Thousand Three Hundred Eighty Pesos and Ninety Four Centavos (P916,380.94); Market (Supplemental Budget No. 3) – One Million Two Hundred Fifty Six Thousand Nine Hundred

Fifty Nine Pesos And Sixty Seven Centavos (P1,256,959.67); Waterworks (Supplemental Budget No. 2) – Two Million Two Hundred Eighty One Thousand One Hundred Sixty Three Pesos And Sixty Nine Centavos (P2,281,163.69), enacted by the Sangguniang Bayan of the said municipality per Appropriation Ordinance No. 13, Series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual, 2023 Edition for Local Government Units and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same,

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety effective December 23, 2024, the Appropriation Ordinance No. 13, Series of 2024 of the Municipality of E.B. Magalona, Negros Occidental, subject to the posting requirements under Section 59 of the Local Government Code of 1991 and the following conditions and reminders:

1. The grant of the Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024 of the Department of Budget and Management;
2. The grant of the Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers shall be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024 of the Department of Budget and Management;
3. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the implementing Rules and Regulations of Republic Act 10121, Commission on Audit Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013; and
4. strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: *“Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) Within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils.”*

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
