***RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 14, SERIES OF 2024, OF THE MUNICIPALITY OF E.B. MAGALONA, NEGROS OCCIDENTAL APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 10 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF ONE MILLION THREE HUNDRED SEVENTEEN THOUSAND TWENTY ONE PESOS AND EIGHTY THREE CENTAVOS (P1,317,021.83) AND THE SUPPLEMENTAL BUDGETS FOR THE ECONOMIC ENTERPRISE; CEMETERY – SUPPLEMENTAL BUDGET NO. 2 IN THE AMOUNT OF TWENTY ONE THOUSAND FIVE HUNDRED PESOS (P21,500.00); MARKET – SUPPLEMENTAL BUDGET NO. 4 IN THE AMOUNT OF FORTY SEVEN THOUSAND FIVE HUNDRED FORTY PESOS (P47,540.00); WATERWORKS – SUPPLEMENTAL BUDGET NO. 3 IN THE AMOUNT OF SIXTY NINE THOUSAND FIVE HUNDRED SEVEN PESOS AND SEVENTY FIVE CENTAVOS (P69,507.75)***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 14, series of 2024, of the Municipality of E.B. **WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

**WHEREAS**, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, and unanimously seconded by all members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 14, series of 2024, of the Municipality of E.B. Magalona, Negros Occidental approving the 2024 General Fund Supplemental Budget No. 14 of the said municipality in the total amount of One Million Three Hundred Seventeen Thousand Twenty One Pesos and Eighty Three Centavos (P1,317,021.83) and the supplemental budgets for the Economic Enterprise; Cemetery – Supplemental Budget No. 2 in the amount of Twenty One Thousand Five Hundred Pesos (P21,500.00); Market – Supplemental Budget No. 4 in the amount of Forty Seven Thousand Five Hundred Forty Pesos (P47,540.00); Waterworks – Supplemental Budget No. 3 in the amount of Sixty Nine Thousand Five Hundred Seven Pesos and Seventy Five Centavos (P69,507.75) that was submitted to the Sangguniang Panlalawigan for review on January 14, 2025 subject to the following conditions:

1. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with the provisions of RA 10121 and its Implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.
2. Strict Adherence in the period as the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of R.A. 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan – (a) within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils;"

**RESOLVED FURTHER**, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

**ADOPTED UNANIMOUSLY.**

This resolution shall take effect immediately upon approval.
