RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY AMOUNTING TO FIVE MILLION TWO HUNDREDTHOUSAND PESOS (\$\mathbf{P}\$5,200,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 5 of the Municipality of Binalbagan, Negros Occidental, with a total appropriation of Five Million Two Hundred Thousand Pesos (₱5,200,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2024-06;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and consider operative in its entirety, the Appropriation Ordinance No. 2024-06 of the Municipality of Binalbagan, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code.
