WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 24-408 of the City of Bago approving Resolution No. 19, series of 2024 of the CDC Executive Committee, Bago City entitled: Resolution approving the Supplemental AIP No. 11 in the amount of P78,973,033.68;
