RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2025-002 OF THE MUNICIPALITY OF CANDONI, NEGROS OCCIDENTAL AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPAL GOVERNMENT OF CANDONI IN THE AMOUNT OF FORTY MILLION PESOS (P40,000,000.00) FROM THE LAND BANK OF THE PHILIPPINES TO FUND THE ACQUISITION OF BRAND-NEW LIGHT/HEAVY EQUIPMENT

WHEREAS, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2025-002 of the Municipality of Candoni, Negros Occidental authorizing the proposed borrowing of the municipal government of Candoni in the amount of Forty Million Pesos (P40,000,000.00) from the Land Bank of the Philippines to fund the acquisition of brand-new light/heavy equipment;

WHEREAS, the power of the Sangguniang Bayan of Candoni to enter into a contract of loan is found in Section 297 of the Local Government Code of 1991 (RA 7160) which provides that:

> Section 297(a) - "A local government unit may contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation or maintenance of public facilities, infrastructure facilities, housing projects, the acquisition of real property, and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender. The proceeds from such transactions shall accrue directly to the local government unit concerned.'
