RESOLUTION NO. 0194 Series of 2025

RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF BINALBAGAN AMENDING SECTION 5F.01, (A) ROOM AND BOARD, (B) ER FEE, (G) LABORATORY FEE, (H) OUTPATIENTS AND (J) OTHER ANCILLARY PROCEDURES, ARTICLE F, CHAPTER V OF MUNICIPAL ORDINANCE NO. 2017-09 ALSO KNOWN AS THE "2017 REVISED OMNIBUS REVENUE CODE OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL"

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2024-06 of the Municipality of Binalbagan amending Section 5F.01, (A) Room and Board, (B) ER Fee, (G) Laboratory Fee, (H) Outpatients and (J) Other Ancillary Procedures, Article F, Chapter V of Municipal Ordinance No. 2017-09 also known as the "2017 Revised Omnibus Revenue Code of the Municipality of Binalbagan, Negros Occidental";

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Binalbagan to enact and in accordance with the Section 16 or the General Welfare Clause of R.A. 7160, otherwise known as the Local Government Code of 1991, as well as Section 186 of the same code which mandates that the LGUs are granted the authority to impose and adjust/taxes, fees and charges in their jurisdiction through ordinances;
